**Reading:** Rachel DeGroat had the second reading of the

Wellness-Sun Safety Policy, number 7662

**Discussion:** 

Rachel DeGroat spoke on behalf of the Curriculum Committee regarding the hiring of a Home and Career teacher for seventh and eighth-grade CTE credits. She asked the Board to consider hiring Anna Bowers to work part-time teaching middle school CTE as well as a 9-12 culinary elective.

Tom Ordway asked if we will no longer have a "shop" teacher and Mike Markwica said they have no applicants. Tom Ordway asked if the kitchen in the Home Economics room was workable. Heather Flanagan said it was. Rachel DeGroat also stated that we are looking for a business teacher.

Sarah Williams said she thought this was a great idea. Jake Sauer-Jones said we should move forward with Anna Bowers and add her to our next agenda.

Rachel DeGroat spoke next on AP or College Courses for next year. The Curriculum Committee would like to offer students, college-level classes, in place of AP classes to help with the start of their college careers.

Mike Markwica stated that there could be a possible cost to the student, unlike in the past.

Rachel DeGroat stated there may be scholarships available to help cover the cost for families in need.

**Motion**:

Tom Ordway thanked Larry Ringer and the Administration for working on the budget.

Rachel DeGroat stated that it was the Board of Educations' decision to go with a 0% tax levy increase this year. Tom Ordway asked where the District was on purchasing electric buses.

Larry Ringer said we will eventually need to change over our buses but we will wait. There will be grant money available.

Tara Sears and Jake Sauer-Jones thanked Allison Gonyo for stepping up to coach. MOTION carried.

#### Wellness Committee:

Sarah Williams reported that the Wellness Committee was working with individuals from the Glens Falls Hospital and federal grants for health and fitness goals. She spoke on the new Sun Safety Policy and a gardening program. Sarah Williams stated that a group visited Granville Central School to see how their food/plant stations worked. She was very excited in the possibilities for our students.

**Updates:** 

Mike Markwica stated that we have been approved to be a school zone. We will need to purchase the signs and lights and the county will cover the poll and installation fees. Tara Sears asked if Mike Markwica looked into the county enlarging the shoulder of Main Street in front of our school.

Mike Markwica stated he did get in touch but has not

received a response yet.
